CISTERN contains a mixture of hydrophilic humectants and hydroscopic compounds that in combination with CISTERN's surfactant blend will enhance plants tolerance to water deficit stress by improving moisture retention in the rootzone. DIRECTIONS FOR GENERAL TURF USE
Greens & Tees, Fairways, Bunker Faces, Collars,
Sports Turf and Parks / Recreation Areas

Apply CISTERN at 6 to 8 oz. (180 -235ml) per 1000 sq. ft. (100 sq. meters) in 2 gallons of water (8 liters) of water – apply every 2 to 4 weeks as required. A light watering-in is recommended after application to ensure CISTERN is moved into the soil profile. CISTERN is safe – NO BURN.

Sodding, Overseeding and Sprigging. Apply CISTERN at 6 -8 oz. (180 -235ml.) per 1000 sq. ft. (100 sq. meters) in 2 gallon (8 liters) of water. Apply every 2 to 4 weeks as required. A light watering –in after application is recommended. To ensure CISTERN is moved into the soil profile.
