Cistern G contains a mixture of hydrophilic humectants and hydroscopic compounds that in combination with CISTERN G's surfactant blend, will enhance plants' tolerance to water deficit stress by improving moisture retention in the rootzone. Cistern G is safe, when used according to the label rates.

DIRECTIONS FOR GENERAL TURF USE

Greens & Tees, Fairways, Bunker Faces, Collars, Sports Turf, Parks / Recreation Areas, Commercial Property, Residential Lawns, and Landscapers

General Turf – Apply Cistern G uniformly at the rate of 1 to 2 pounds per 1000 sq. ft. Apply every 2 to 4 weeks as required. A light watering-in is recommended after application to ensure Cistern G is moved into the soil profile. Cistern G is safe – NO BURN.

Sodding, Overseeding and Sprigging. Apply Cistern G at the rate of 1 to 2 pounds per 1000 sq. ft... A light watering-in after application is recommended. To ensure Cistern G is moved into the soil profile. Do not apply to wet turf conditions.
