FIRST AID MEASURES IN CASE OF CONTACT

DIRECTIONS FOR GENERAL MEDIA USE

General Substrate Applications: Apply Fountainhead at 2 – 4 fl oz. per cubic yard (45 – 90 ml per cubic meter). Apply Fountainhead in enough water to ensure uniform coverage throughout the substrate. Spray surfactant solution uniformly during blending of media.

For Harder to Wet Substrates: Apply Fountainhead at 4 – 7 fl oz. per cubic yard 90-160 ml per cubic meter). Apply Fountainhead in enough water to ensure uniform coverage throughout the substrate. Spray surfactant solution uniformly during blending of media.

Ornamentals Production Use Rates: Fountainhead should be applied in a 400 to 600 PPM (5.1 – 7.6 fl oz. /100 gal of water or 150-225 ml /400 liters of water) drench procedure. Fountainhead can be reapplied at a 400 to 600 PPM drench every 6 weeks or as needed.

For Untreated Substrates or Harder to Wet Substrates during production: Apply Fountainhead at 500 to 600 PPM (6.3 – 7.6 fl oz/100 gal of water). Reapply Fountainhead on a 7 to 10 day intervals.

For Treatment Prior to shipment: Apply Fountainhead at 400 to 600 PPM (5.1 – 7.6 fl oz per 100 gal of water or 150-225 ml. / 400 liters of water) 1 to 2 weeks before shipment of plant material.

Fountainhead can be applied through fertilizer and irrigation injection systems.
