Apply Poseidon at 4 – 6 oz. (120 - 180 ml.) per 1000 sq. ft. (100 sq. meters) in 2 gallons (8 liters) of water. For best results, apply as a 30 day preventive program monthly throughout the growing season. Poseidon should be applied before the symptoms of water repellency appear. No watering-in is required when used at recommended rates.
