**Greens, Tees, Fairways, Lawns and Sports Turf**

**Localized Dry Spot and Water Repellency Conditions:** Apply RETRO 4 to 6 oz. (120 ml to 160 ml.) per sq. ft. (per 100 meters squared) on a 30 day program before the symptoms of water repellency appear. RETRO should be applied in a 2 gallon (8 liter) spray solution per 1000 sq. feet (100 sq.meters).
