## DIRECTIONS FOR GENERAL TURF and Ornamentals USE

**Turf:** Apply NuHumic WDG at 40 to 180 pounds per acre per year. Apply at 1 to 1.85 pounds per 1,000 sf. during the growing season. Can be at time of aeration as top dress application NuHumic WDG can be applied anytime during the season.

**Trees and shrubs:** Apply at 2 to 7 oz. as a band application around the base of trees or shrubs.

**Ornamentals:** Apply at 1 to 1.5 pounds per 1,000 sq. as a broadcast application.

**Substrates and potting soils:** Mix evenly at 2 to 6 pounds per cubic yard.

**Crop Applications:** Apply NuHumic WDG at 30 to 40 per pounds per acre per year or as needed. NuHumic WDG can be applied with other fertilizer applications. Spreading of NuHumic WDG can be by broadcast or band applications. If in brand applications apply 3 to 9 pounds per acre.
